# Mission-original handcrafted local arts & craft (2023)

### OBJECTIVES OF Artisans Nest Inc. (2025)

- 1. To enable the collaboration and inspiration of creative ideas between members.
- 2. To raise awareness and appreciation of, and access to, arts and crafts including wearable art in our local area through the promotion, display and sale of members' work.
- 3. To provide a venue to increase awareness of regional art and to distribute information for the cultural benefit of visitors and members of the local community.
- 4. To provide financial and educational support to locally emerging artist and crafters.
- 5. The assets and income of Artisans Nest Inc will be applied solely to its abovementioned objects and no portion shall be distributed directly or indirectly to the members of the organisation except as bona fide compensation for services rendered or expenses incurred on behalf of the organisation.
- 6. In the event of Artisans Nest Inc. being dissolved, the amount that remains after such dissolution and the satisfaction of all debts and liabilities shall be transferred to another organisation with similar purposes which is not carried on for the profit or gain of its individual members.

### Policy and Procedure

- When joining, members are approved to sell the type of work outlined at time of their application. Any changes or additions to be approved by committee.
- All items must be clearly labeled with your name, code and number, fibre content, care
  instructions if appropriate, and selling price. The same code and a description must be
  entered on Square point of sale system.
- ARTISANS NEST will take responsible and reasonable care of all goods but will not
  accept any responsibility for damage or theft.
- Members are required to be rostered for at least two duty days per month in the Gallery/shop. One member is rostered daily. Extra days to be worked in advance to gain credits prior to any months when a member is unable to do roster.
- Artisans Nest Inc. will retain a 20% commission on all sales from the gallery including referrals or orders generated from Artisans Nest. The artists' percentage of sales is 80%, paid monthly within 30 days of the end of the month in which the sales occurred.
- Current Fees -\$40 annual membership subscription paid by 31 December in advance.
   Monthly display fee is \$20 a month paid twice a year, by 31 December and 30 June.
   You will be notified of fees payable if accepted as a member.
- From the fees and commissions Artisans Nest Inc. will pay for operating expenses
  associated with the Gallery /shop rent, basic display fixtures, advertising, packing
  materials, office supplies, etc. Members requiring special display fixtures for their
  work may be required to supply these and this may be subject to the approval of the
  group.
